Workshop 4: Nature Positive Water – Partnering with utilities for impact

Interested in understanding how the water sector can contribute toward our Nature Positive goals in Australia? Keen to hear First Nations perspectives on partnering with water utilities to heal Country? In this workshop, we will explore how water utilities are contributing to a Nature Positive future, along with emerging opportunities to partner with private landholders and community groups to scale action.

We will hear about current initiatives and case studies from the Australian water sector, drawing from the recently released WSAA paper – <u>Nature Positive Water</u>, August 2024. We will explore how understanding impacts and dependencies on nature, can support the water sector to provide resilient water and wastewater services for future generations, moving from water managers to water stewards, contributing toward Australia's Nature Positive goals.

The workshop will cover three key themes:

- Partnering with water utilities First Nations perspectives and opportunities
- Where we are now water utility case studies with panel and group discussion

• Where we can go – exploring partnerships to scale action inspired by global case studies shared by The Nature Conservancy (TNC),

This will be followed by panel discussion sharing learnings from current water utility case studies and group discussion. We will round up to focus on future opportunities to scale action. The workshop segments will be inspired by First Nations perspectives, Australian water utility case studies and global case studies from TNC, sharing how Water Funds have enabled pooling of resources between stakeholders to scale action. We welcome First Nations people, water utility professionals, private landholders, government and academic representatives and conservation or community groups to explore how to get rubber on the road for scaling action, delivering benefits to community and nature now and for future generations.
